



## Refer-a-Friend Promotion - Official Rules

### No Purchase Necessary

#### ELIGIBILITY

The MedicalMime Refer-a-Friend promotion is open only to (i) medical practices or treatment facilities that are current customers in good standing of MedicalMime, Inc. ("Eligible Practices") and (ii) consultants designated by MedicalMime as eligible to participate in this promotion ("Eligible Consultants"). The recipient of any referral award must be a legal resident of the United States who is at least eighteen (18) years of age and employed or engaged by an Eligible Practice or Eligible Consultant. Employees, agents and members of their immediate families and households of (i) MedicalMime, its affiliates and its advertising and promotion agencies, (ii) partners or vendors of MedicalMime, or (iii) anyone involved in the production, development or handling of this promotion are not eligible to participate in this promotion.

#### SIGNED AGREEMENT OFFER

Upon satisfactory execution of a MedicalMime license agreement and accompanying documentation by a medical practice or treatment facility referred by the recipient, MedicalMime will present the recipient with \$500.00 per full-time equivalent ("FTE," as defined by MedicalMime) provider licensed under such agreement (up to a maximum of three FTE (3) providers for a maximum award of \$1,500). Eligible license agreements must be executed within sixty (60) days of the date of referral. The acceptance of any signed license agreement shall be subject to MedicalMime's sole discretion. The signatory of any such agreement must have authority to execute agreements on behalf of the signer's employer with respect to the purchase or selection of an Electronic Health Record product. Award recipients are solely responsible for applicable taxes. No substitutions will be made except at MedicalMime's sole discretion. Limit one (1) award per practice or facility referred.

#### GENERAL CONDITIONS

Recipients should allow up to ninety (90) days following satisfactory completion of all program requirements to receive awards earned under this promotion. Referrals of existing MedicalMime customers and/or sales prospects already in the MedicalMime pipeline shall not be eligible for award under this program. Referrals made prior to the start date of this promotion are ineligible for consideration under this program. No more than one referral award shall be made in each category with respect to a particular medical practice or treatment facility. Referral awards will not be made with respect to an existing MedicalMime customer adding physicians or treatment sites to its practice, or with respect to a medical practice adding new clients to its existing relationship with MedicalMime. Duplicative referrals are not eligible for award under this program. MedicalMime shall have the right to interpret these Official Rules in its sole judgment and discretion, as well as to make any decisions with respect to the validity or eligibility of a referral. All decisions of MedicalMime are final on all aspects of this promotion. This promotion is subject to these Official Rules and all federal, state and local laws and regulations.
